Invitation to Bid for *Construction of Production Wells*

1. The *Municipality of Tubigon*, through the *budget for the contract approved by the Sangguniang Bayan (General Fund and Trust Fund)* intends to apply the sum of **One Million Pesos (PhP1,000,000.00)** for **Lot 1 - Construction of Production Well in Barangay Ilijan Norte - Contract No. 2016-300-0901** and the sum of **Seven Hundred Nine Thousand Seven Hundred Twenty-Five and 22/100 Pesos (PhP709,725.22)** for **Lot 2 - Construction of Production Well in Barangay Villanueva - Contract No. 2017-100-0902** being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The *Municipality of Tubigon* now invites bids for the above Procurement Project. Completion of the Works is required within **Ninety (90) Days** for each lot. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Municipality of Tubigon* and inspect the Bidding Documents at the address given below from **8:00 AM to 4:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **29 October 2020** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (P1,000.00) for each lot*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person or through electronic means*.
6. The *Municipality of Tubigon* will hold a Pre-Bid Conference on **05 November 2020, 2:00 PM** at the *Municipal Planning and Development Coordinator (MPDC) Conference Room, 2nd Floor Municipal Administrative Building, Potohan, Tubigon, Bohol* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **19 November 2020 before 2:00 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.

9. Bid opening shall be on **19 November 2020 at 2:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Municipality of Tubigon* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
